Acceptance of terms and Conditions

I, the undersigned _____ ID No. _____
(hereinafter referred to as “*The Card Holder*”) have acquired from **Gozo Channel Company Limited**
(hereinafter referred to as “*The Company*”, a Daily Commuter Travel Card valid for 50 trips between Mgarr
(Gozo) and Cirkewwa (Malta) valid from _____ to _____ (3 months).

I hereby accept and undertake to abide by the terms and conditions of the Daily Commuter Travel Card as listed hereunder:

1. The scheme is available only to:
 - a. persons travelling between Malta and Gozo for employment purposes and;
 - b. full time Gozitan students attending tertiary education in Malta
2. Trips not used within the card's validity period will automatically expire at the end of the period.
3. Cards sold are not refundable.
4. The Company reserves the right to refuse issue or renewal of the Travel Card at its own discretion.
5. The Travel Card remains the property of the Company and is to be shown to Company staff or designated officials upon request.
6. A card that has been mislaid or lost, or which has been defaced, rendered illegible, torn, or otherwise tampered with, and thus not valid for use, can only be replaced at a charge of €11.65 (eleven euro sixty five cent) (Lm5) per card.
7. The scheme may not be used in conjunction with any other offer that the Company might issue from time to time.
8. Cards cannot be upgraded or exchanged with other Company offers under any circumstances.
9. Card Holders who at the point of travel declare that they have mislaid or forgotten their card will be obliged to pay the normal fare which will be non refundable.
10. The Card is non-transferable and under no circumstances can it be used by a person other than the card holder.
11. The Card must be carried by the Card Holder at all times during a journey that is charged to the card. Should a Card Holder fail to present the Card when requested to do so by a Company representative, he/she will be required to pay the normal fare which will be non-refundable.
12. The Daily Commuter Travel Scheme is applicable only to private Non-Commercial Vehicles up to 5 metres in length. This scheme is intended for passenger-carrying vehicles and specifically excludes vehicles designed for the carriage of goods.
13. Abuse of the Travel Card including, but not limited to, the use of the card by someone other than the card holder, or for the purpose of embarking a commercial vehicle or any vehicle which is not attached to the travel card will lead to its withdrawal without any compensation whatsoever for any unused trips.
14. If the ferry prices change during the validity period of the Card, the number of trips covered by the Card may be changed to reflect the monetary value of the Card at that time.
